Introduction

The objective of the project, which started in 2016, is to revitalize the MERIC network (Mediterranean Recognition Information Centers) in order to facilitate recognition and contacts between the recognition authorities in the Mediterranean and European region. The project also more globally aims at favoring and increasing the recognition of qualifications, improving the competencies and skills of credential evaluators as well as raising the quality of mobility in higher education systems.

The current document is the Dissemination Report of the MERIC-Net project. The aim of the Dissemination report is to present and analyze the visibility and communication infrastructure of the project throughout the project's events and activities. In order to assess the promotion and exploitation of the project results, different types of elements from events reports to social media posts are presented hereafter.

Reporting on dissemination and communication activities is understood as the transversal activity of promoting the project and its results to an extended audience beyond the project consortium. In the case of the MERIC-Net project, it can be said that the dissemination and communication of the project results raise awareness about the project objectives, activities and results, as well as the needs it was addressing.

The project involves 19 partners from 7 countries (Algeria, France, Italy, Lebanon, Morocco, Norway, Tunisia) in a 3-year project


Social Media

In addition to the project website, Social Media are used to disseminate events and achievements, as well as to promote discussions and engage researches, stakeholders and university staff.


Social networks proved useful for establishing a continuous interaction with project stakeholders, for keeping daily interest towards project initiatives and events and for sharing key achievements. The main objectives of social media are:

- ✓ Spreading project information, activities and results
- ✓ Broaden the outreach of MERIC-Net
- ✓ Exchanging experiences
- ✓ Allowing the creation of a very interactive dissemination
- ✓ Analysis of the audience feedback to adjust the communication strategy

Mainly Facebook and Twitter posts have been used. The main hashtags used for MERIC-Net are #mericnet and #mericnet. A list of all the posts related to the MERIC-Net project and shared on social media are available in Annex I. Specifically, on the types of social media used, it appears that Twitter has been more used than Facebook.



Overall on social media, the impressions have been positive.







This image details the keywords associated the most to the MERIC-Net project throughout the posts shared on social media. The concepts of "qualifications", "procedures", "higher education institutions", "project' and "recognition" appear the most in such social media posts.

News

News have been written and published following events and meetings. Partners shared the project's news within their network of contacts.

For example, articles have been published on UNIMED website for the first final conference in Tlemcen here, for the second final conference in Nice here, and here for the dissemination of the MERIC-Net video here. MERIC-Net Events and Activities

Events are diverse in the framework of the MERIC-Net project. They help engaging stakeholders through discussion and confrontation, presenting the project and involving the audience in its development, measuring the impact of project outcomes and receiving feedbacks and inputs for future implementation. Participation in conferences and workshops represent an opportunity to promote the project, to learn about new developments in higher education, to connect with other universities and research centers.

Activities taking place in the framework of the project include face-to-face trainings and internships for government officials and university staff from Algeria, Lebanon, Morocco and Tunisia to provide them with knowledge on EU higher education systems, recognition practices and National Recognition Centers, and fostering their capacity in academic recognition procedures. Online trainings and seminars on transnational education and on the recognition of refugees' qualifications, as well as monitoring visits are also marking the lifespan of the project.

Project Meetings

The kick-off meeting in February 2017 in Marrakech introduced the project activities and gave the chance to get to know all the project partners from Algeria, Lebanon, Morocco, Tunisia, Norway, France and Italy. It was the moment to present the single project activities and tasks to the single partners and talk about administrative and financial issues.

The second Consortium Meeting in December 2017, which took place in Rome, summarized the activities done by the partners so far and their feedbacks on the single actions.

It was the moment to present the structure of the National Report and to define the deadlines of the future activities like the dissemination of project results as well as the financial and administrative issues. It was a moment of open discussion where all the partners of the project where highly involved.

Face to face training

Face-to-face training in Algeria

September 2017



Goverment officials from the Algerian Ministère de l'Enseignement Supérieur de la Scientifique participated in a face-to-face trainig on diploma recognition issues, credential evaluation procedures and national regulations in September 2017 in Algiers. Experts from the French, Italian and Norwegian ENIC-NARIC centres CIEP, CIMEA and NOKUT discussed with the participants the contents of the on-line training course that the participants had successfully completed.



Face-to-face training in Lebanon

September 2017



After the successful completion of an on-line training course, an intensive face-to-face training week for Goverment officials in the Ministry of Education and Higher Education in Beirut was taking place in September 2017. Diploma recognition issues, credential evaluation procedures and national regulations were discussed with the trainers from the French, Italian and Norwegian ENIC-NARIC centres CIEP, CIMEA and NOKUT.



Face-to-face training in Morocco

October 2017



After the successful completion of an on-line training course, an intensive face-to-face training week for Goverment officials in the Ministère de L'Enseignement Supérieur, de la Recherche Scientifique et de la Formation des cadres in Rabat was taking place in October 2017. Diploma recognition issues, credential evaluation procedures and national regulations were discussed with the trainers from the French, Italian and Norwegian ENIC-NARIC centres CIEP, CIMEA and NOKUT.

Face-to-face training in Tunisia

October 2017



Goverment officials from the Tunisian Ministry of Higher Education, Scientific Research, Information and Communication Technologies participated in a face-to-face training on diploma recognition issues, credential evaluation procedures and national regulations in October 2017 in Tunis. Experts from the French, Italian and Norwegian ENIC-NARIC centres CIEP, CIMEA and NOKUT discussed with the participants the contents of the on-line training course that the participants had successfully completed.

Face-to-face training at the University of Palermo

November 2017



An intensive training for administrative staff from the Algerian, Lebanese, Moroccan and Tunisian partner universities was taking place in the premises of the Università degli studi di Palermo in November 2017. The training was provided by the European partners of the MERIC-Net project - the Universities of Palermo, Oslo and Nice and the French, Norwegian and Italian ENIC-NARIC centres - to train the administrative staff in recognition of foreign qualifications, European Higher Education systems, Joint Programmes and Quality Assurance. As a preparation to the face-to-face training, the participants took a six-weeks online-training course in October and November 2017. After the face-to-face training in Palermo the Algerian, Lebanese, Moroccan and Tunisian university staff split up in three groups and went on study visits to the European partner universities in order to deepen their knowledge in topics of the training.

Internship in the French, Italian and Norwegian ENIC-NARIC Centres

October-November 2017



In October and November 2017 five government officials from the Algerian Ministère de l'Enseignement Supérieur et de la Recherche Scientifique and 6 government officials from the Lebanese Ministry of Education and Higher Education were welcomed in Paris, Oslo and Rome to spend a three-weeks internship period in the ENIC-NARIC centres of France, Norway and Italy. This internship was useful to deepen their knowledge of recognition procedures, discuss about credential evaluation and the Bologna Process and learn about European Higher Education systems.



Internship in the French, Italian and Norwegian ENIC-NARIC Centres

January 2018



In January 2018 three government officials from the Morocco Ministère de l'Education Nationale, de la Formation Professionnelle, de l'Enseignement Supérieur et de la Recherche Scientifique and five government officials from the Tunisian Ministère de l'Enseignement Supérieur et de la Recherche Scientifique were welcomed in Paris, Oslo and Rome to spend a threeweeks internship period in the ENIC-NARIC centers of France, Norway and Italy. This internship was useful to deepen their knowledge of recognition procedures, discuss about credential evaluation and the Bologna Process and learn about European Higher Education system. Moreover, it was an enrichment experience for the ENIC - NARIC centres to deal in depth with Higher Education systems of the Mediterranean countries and their recognition procedures.

April 2018



Experts from the French, Italian and Norwegian ENIC-NARIC centers CIEP, CIMEA and NOKUT visited the Tunisian Ministry of Higher Education in April 2018 to learn more about the national recognition procedures and define a common action plan to further develop the restructuration of the direction of equivalence in the Tunisian Ministry of Higher Education. A cascade training was organized with colleagues from Université de Tunis Al Manar and University of Monastir in order to pass on the knowledge gained during the training activities to the other colleagues at the Ministry.




Monitoring Visits at Universities in Algeria, Lebanon, Morocco and Tunisia

September 2018-February 2019



Between September 2018 and February 2019 Monitoring Visits at Universities in Algeria, Lebanon, Morocco and Tunisia were jointly taken with the participation of experts from both administrative staff of Universities and ENIC - NARIC centers. The visit of European experts aimed to share ideas on evaluation procedures and discussed about useful tools to improve recognition procedures of foreign qualifications based on the lessons learned through the previous activities.

Three MOOCS have been realized on the recognition of qualifications held by refugees.



Seminars

Two seminars have been realized in October 2018.

On seminar was dedicated to the Recognition of Qualifications held by refugees. It took place in Beirut in October 2018. As a result of the meeting and part of the outcomes of the project a "Guidelines for the recognition of refugees, displaced persons and persons in a refugee - like situation" was written and available on the website.

Final Project Meetings

In order to ensure that the values and goals of the project are well understood and adopted by decision makers and policy makers at the partner HEIs, as well as the other stakeholders of the project, two final conferences were organized: the first was held in Algeria (Algiers) and the second in France (Nice). During both conferences, were invited all the relevant stakeholders (HE institutions and official bodies) of each country involved in the project and of other countries from the same regions (Europe and South-Mediterranean countries).

In April 2019, the **First Final Meeting** was organized and hosted by Tlemcen University. During the Meeting, Universities' staff and representatives of the Ministries of Higher Education were highly committed in presenting the lessons learned during the project's life time. NARIC partners and EU universities reported the results of the Monitoring visits taken at Universities, providing suggestions that will encourage the international student mobility and smooth recognition procedures of qualifications in the Mediterranean area.

MERIC-Net Achievements

The achievements of the MERIC-Net project notably include **four national reports** on Algerian, Lebanese, Moroccan and Tunisian education systems, official Higher Education Institutions, study programs, qualifications and peculiarities with the aim of facilitating the circulation of clear and complete information, which is useful both for credential evaluators and students. The project also led to the elaboration of **guidelines** for the evaluation of non-traditional, cross-border or trans-national education and distance learning institutions and their qualifications in order to foster up-to-date recognition practices, as well as to the elaboration and practice-sharing of **procedures for the recognition of refugees' qualifications**. All these deliverables are available on the website of the project.
